Affiliate Memorandum of Understanding for American Registry for Internet Numbers (ARIN)

Purpose

This Memorandum of Understanding (“MOU”) outlines a nonfinancial, mutually beneficial partnership between the **Marconi Society** and **ARIN** to advance the objective of increasing Internet Resilience, including fostering global dialogues, promoting innovation, and addressing key challenges. This partnership will leverage the expertise and networks of both organizations to support impactful initiatives, events, and thought leadership.

Shared Goals

- Strengthen international cooperation across technical, regulatory, and policy domains.
- Leverage ARIN leadership and the Marconi Society’s convening power.
- Amplify awareness of Internet Resilience, challenges and solutions.
- Identify opportunities for program collaboration, knowledge-sharing, and youth engagement.

Marconi Society will provide:

- **Visibility and Speaking Opportunities**
 - Recognition and publicity.
 - Highlight in an upcoming newsletter and event materials.
 - Option to collaborate on sessions and speaker recommendations.
- **Affiliate Acknowledgement**
 - Logo placement on the Marconi Society’s Affiliate’s webpage.
 - Recognition on marketing collateral and promotional materials.
 - Affiliate relationship recognition during general sessions and opening remarks.
- **Event Engagement**
 - Opportunities to participate in future convenings (e.g., Executive Forum, Internet Resilience Forum).
- **Program Access and Integration**
 - Alignment between ARIN’s governance and standards initiatives and the Marconi Society’s Internet Resilience Institute.
 - Collaboration opportunities with the Young Scholars and the Internet Resilience Institute.

ARIN will provide:

- **Affiliate Acknowledgement**
 - Placement of the Marconi Society's logo or mention on a relevant page or affiliate section.
- **Promotion and Awareness Building**
 - Promote Marconi Society initiatives, events, and programs through ARIN's professional network (members, committees and networks), amplifying reach and impact.
- **Speaker and Program Development**
 - Collaborate in identifying, securing, and introducing high-value speakers, panelists, or contributors for Marconi Society programs and events.
 - Establish relations between the Senior leadership of ARIN and the Marconi Society.
- **Strategic Input**
 - Where applicable, collaborate on program development or co-organize sessions related to shared priorities.


Non-Financial Commitment

This non-financial MOU is based on the mutual alignment of goals and shared contributions of time, expertise, and networks.


Term and Review

This Memorandum of Understanding will commence on the date of signing and remain in effect for one year, with the intent for renewal based on mutual agreement.
