- ACSP 2017.2 Removal of Point of Contact (POC) from an organization resulting email notification now includes the POC handle
- ACSP 2017.12 Revisions to ARIN Consultation and Suggestion Process form
- ACSP 2016.09 No valid POC resource report updated
- RPKI Trust Anchor has been modified to reflect all holdings (0/0)
- ACSP 2015.6 Transfer statistics now available via FTP





- POCs can now perform verification by replying to the validation request email
- Ability to modify and reassign networks and delete reassignments from search results page
- Technical Debt (various upgrades and infrastructure improvements)
- Web Accessibility and UX/UI work
- Implement Postgres solution for ACSP 2012.20: Remove Result Limits for Whois-RWS Child Network Queries
- Unlimited result sets for queries from authenticated users via RDAP

ARIN Consultation and Suggestion Process (ACSP) Update



- Presently 29 are open and of those 28 require engineering work
- Processed 21 ACSP requests within the last two calendar years
 - 3 SPAM
 - 1 referred to PDP
 - 6 completed by Engineering
 - 4 declined
 - 7 completed by CMSD or others
- Some ACSPs require a very heavy engineering lift not all ACSP are equal
 - 3 ACSPs are tied directly to the Internet Routing Registry Project ARIN Services Working Group considering direction
 - 2011.17 "Define access restrictions for APIs"
 - Need to define framework for ACLS for various API Keys
 - Need to then enforce ACL's for those API Keys
