- Six Items sent to the Board of Trustees:
 - ARIN-2017-12: POC Notification and Validation Upon Reassignment or Reallocation
 - ARIN-2018-5: Disallow Third-party Organization Record Creation
 - ARIN-2018-6: Clarify Reassignment Requirements in 4.2.3.7.1
 - ARIN-2019-3: Update 4.10 IPv6 Deployment Block
 - ARIN-2019-8: Clarification of Section 4.10 for Multiple Discrete Networks
 - ARIN-2019-15: Hijacking Authorization Not-intended
- All adopted at the 22 January 2020 Board of Trustees meeting
- All implemented 31 March 2020 by staff in Number Resource Policy Manual (NRPM) Version 2020.1
