The why?


- Reduce the number of allocations needed for a growing network to provide for better aggregation.
- To bring continuity to allocation practices between the RIRs. While a global policy may be the better route, it is easier to change the policy of one RIR rather than the other four.

Does this proposal move in the wrong direction and promote hoarding?

- Hoarding is based on the assumption that the application review process is flawed. This should not be addressed in this policy.
- Is the timeframe the best means to regulate this issue. If false documentation is being provided, the timeframe won't matter. There are proposals to provide auditing capabilities, which is where the review should happen. We shouldn't restrict organizations that are legitimately growing.

Does this move in the wrong direction and increase the “run on the bank”?

- This proposal does not alter the demand curve. The slow start method of allocations and the application review process are the throttle, not the timeframe. The allocations to established organizations are based on historical growth.
