

The suggested reserve is 25 /8s, 5 per each RIR. When the IANA can not fulfill the last RIR request, they will give what they can to that RIR. The IANA will then allocate the 5 /8s to each RIR.

# Policy Proposal 2007-25 Description

- ARIN staff understands that this proposal would make the following changes to the IPv6 section of the NRPM:
  - Semoves the prefix size from the initial IPv6 allocation criteria,
  - $\Rightarrow$  Moves a modified version of 6.5.3 to a new location (6.5.4.4),
  - Establishes criteria for direct assignments larger than a /48 (.94 HD-Ratio), and
  - Makes reserved space (from the /44s) available for other use.
